Due to the crowd size, an exterior perimeter was established outside of the initial crime scene. I remained on scene to assist with crowd control and ensuring that no unauthorized persons entered the crime scene. I had no contact with any witnesses, victims, and/or suspects. All contact on scene was recorded with my department issued BWC.
